KMGC and are referred to collectively, as "Parties" or individually as "Party."

1. Purpose

The Parties recognize the benefits to be derived from fincreased collaboration, cooperation and interaction for the further research and development activities on Biochemistry and Biotechnology (hereafter, collectively referred to as the "Field").






