- 5. Board suggested to exclude the topics which are repetitive in more than one course. So in core paper I: Principles of Management in unit V the topic "External Environment" to be removed, since the topic is covered in semester IV, Core paper VII "Business Environment".

6. Board suggested to opt "Tourism Management" from the three options "Hotel Management", "Airport Management" & "Tourism Management" as value added course, Since "Tourism Management" course have more practical exposure for students.
