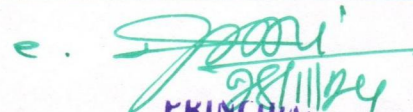
Recommendations and Resolutions:

7. The Board recommended to include a List of Practicals in the paper Mobile Development Practical (APCPIT23).
8. Latest Text and Reference Books must be referred with Edition and Year as per the recommendation of the Board Members.
9. Uniformity should be maintained in the list of exercises in every practical paper as per the recommendation of the Board.
10. The Board recommended to include Multi Modal Biometric in the 5th Unit of the paper Biometric Techniques (APEIT24C) - Elective III.
11. The Board recommended to include Application Tools such as Rational Rose in the case studies of the paper Object Oriented Analysis and Design (APEIT25B) – Elective IV.
12. The committee suggested to include Real Time Modules in the paper Software Project Management (APEIT25C) as part of Case Study.
13. The Board recommended to encourage the students to do Mini Project in Cyber Security and they may be given assignments and seminars on the same to get more awareness.
