As preparations with respect to implementation of Autonomy, such as issue of College Prospectus with Course Structure have to be done and also the conferment of Autonomous Status is to be approved by the Governing Body and subsequent action taken by the Principal of the College for implementing Autonomy for all First Year UG & PG programs from the academic year 2024-2025 is to be approved.
