CENTRAL GOVERNMENT SCHOLARSHIP

National Scholarship

National Scholarship Portal (NSP) is an Online Government Portal started for students to provide information regarding all state & central government scholarships. The official website link of NSP is "scholarships.gov.in". The portal also provides an online registration system for eligible students to apply online for various scholarships. The National Scholarship Portal was launched by the government to provide scholarships details, here you can also check your Scholarship Application Form Last Date, Status, Payment Status, etc. The portal creates transparency of the database of scholars to reduce frauds in scholarships. The portal also helps scholars to get their scholarship amount directly in their bank account.

1. Scholarship Name: Financial Assistance for Education of the Wards of LSDM Workers /Beedi/Cine/IOMC/-Post-matric and Pre-matric.

The family income should not exceed

- Rs.10, 000/- per month for Beedi and Mine workers.
- Rs.8, 000/- per month or Rs.1, 00,000/- for Cine workers.

Eligibility

- One of the parents of the student should be Beedi, Limestone & Dolomite Mines, Iron Ore Manganese & Chrome Ore Mines, Cine worker with at least six months service
- · Students should pass the previous exam in the first attempt.
- Correspondence course students are not eligible for the scholarship.
- The educational institutions of the student must be a government recognized or government institute.
- If a student is availing any other scholarship from any source then they are not eligible for scholarship under this scheme.
- 2. Scholarship Scheme Name-Central Sector Scheme of Scholarships for College and University Students

Scholarship Amount-

- For UG Courses- Rs. 10000/- per annum.
- For PG Courses- Rs. 20000/- per annum

Eligibility-

- Age Limit- 18-25 years.
- The attendance must be 80% or above in Class 12th and are eligible for this scheme for pursuing further studies.
- Family Income should not be less than Rs. 8 lakh per annum.

National Scholarship Required Documents

- > Educational documents of student.
- Student's Bank account number and IFSC code of the bank branch.

 Note: For pre matric scholarship scheme, where students do not have their own bank account, parents can provide their own account details. However, parents account number can only be used against scholarship applications for maximum two children.
- Aadhaar number of the Student.
- ➤ If Aadhaar is not available, then Bonafide student certificate from Institute / School and Aadhaar Enrolment ID or Scanned copy of Bank passbook.
- If Institute/School is different from domicile state of the applicant, then Bonafide student certificate from Institute / School.

3. MINORITY SCHOLARSHIP

The Prime Minister's New 15 Point Programme for the Welfare of Minorities was announced in June, 2006. It provides that a post-matric scholarship scheme for meritorious students from minority communities would be implemented.

The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education increase their rate of attainment in higher education and enhance their employability.

Scholarship Scheme Name: Central Sector Scheme of Scholarships for Minorities **Eligibility**:

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardians from all sources does not exceed Rs.2.00 lakh.

Distribution:

Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act, 1992. A total of five (05) lakh scholarships are targeted to be distributed as 'Fresh' Scholarships, besides, Renewal scholarships. The distribution of scholarship among the States/Union Territories will be made on the basis of population of minorities in the States/Union Territories as per Census 2001 for 2017-18 and as per the population of minorities in the States/Union Territories of Census 2011 for 2018-19 and 2019-20 (as per Appendices- A & B).

Eligibility Criteria for SC ST Scholarship Tamilnadu

Students who want to apply for the scholarship should be residential of Tamil Nadu. The students should belong to Schedule Tribe and Caste. The Annual Family Income should be less than 2.5 lakh from all the sources. Students should have passed their previous exam with a minimum 50%. The student should be enrolled in an institution which is located in Tamil Nadu.
